Seniors awarded diplomas at EPS

ELGIN — Every life lived is marked by chapters. One door closes and another one opens.

For the graduating seniors at Elgin Public School such an event occurred late Saturday afternoon.

Years of public education came down to one final moment, graduation.

The gymnasium, for close to an hour was full of words, warm embraces and a few tears, all wrapped up in the

awarding of diplomas.

Giving the 'Charge to the Class' was 2014 graduate Ivy Prater. Having flown home from her home in Arlington, VA., Prater put the day in perspective for this year's graduates.

"I know you're all excited to toss those graduation caps and never look back at textbooks again, but I have some news for you: you're not done learning," she said. "You'll learn plenty from your experiences, your coworkers, your mistakes ...you'll also learn from leaps of faith for better or worse."

She urged each to live in the moment. "Take this memory (graduation) and store it to look back on. We know memories, both good and bad, can be used as treasures ... As you figure out your journey, just remember that it's the moments that truly matter.

She closed by stating three important lessons she hopes all will remember: "Be a lifelong learner, be adaptable and live in the moment."

Giving the Valedictorian Address was William Heilhecker. He used anecdotes from his years at school to show how each was a lesson to learn from.

"With each challenge passed, you surmount another hurdle in your way,

District #18 board okays purchase of new activity bus

May means the end of the school year is in sight for students.

For administration and school board members, May means starting the process of getting ready for a new school year.

The District #18 Board of Education last week took a number of steps, some which will be noticeable in the coming weeks and months and another may take close to a year to be noticed.

The biggest step taken by the board was approving the purchase of a new diesel activity bus. With their current activity bus aging, the board approved the expenditure of \$133,550 to purchase a 21-passenger bus from Cornhusker International.

The current fleet of school buses operated by the school district are Blue Birds, this marks the first International to be added to the mix.

It was noted that by going with the International brand, the school would save between \$13,000 to \$15,000 compared to the cost of the Blue Bird bus.

Among the many features, the new bus will have air conditioning as well as air brakes.

Superintendent Mike Brockhaus said the school will

have to wait nine to 12 months for delivery. The school plans to trade in the old activity bus, which will lessen the final cost.

In other action:

Bid approved — Needing repairs to be made to various doors and classroom cabinets, the board approved a bid from Cedar View Carpentry in the amount of \$6,250.

Espanol — The board approved the purchase of an online Spanish Classroom for one year at a cost of \$23,000.

Demolition — The board approved a bid just short of \$6,000 for Environmental Services for the demolition of the kitchen ceiling, lobby and restroom ceilings in the gymnasium.

For sale — With a number of surplus iPads and other technology devices, the board approved the sale or, if necessary, disposal of such items.

Approved — Handbooks for teachers, students, employee and elementary, all having been updated, have been approved with changes for the 2023/2024 school year.

Cement replacement — B&S Construction will be doing work on school property in the coming weeks. The board approved a cement replacement bid for \$5,816.

COFFEE CAKE

2 cups flour
1 stick butter

Grease a 9x13 pan. Mix the above ingredients (the batter will be thick) and spread in the pan. Top with 2 cups of apple pie filling. Make a mixture of 1 stick butter, 1 cup flour and 1 cup sugar and use a pastry cutter to make it crumbly. Spread over top of the pie filling. Bake at 350° for 60-70 minutes.

BUTTERSCOTCH ROLLS

1 pkg frozen rolls (Rhodes)
1 pkg butterscotch pudding (NOT instant)
1/2 cup brown sugar

Nuts, if desired
1/4 cup melted butter

Grease a bundt pan slightly. Place 1/2 of the nuts in bottom of the pan. Place the frozen rolls in the pan. Sprinkle on brown sugar and the remaining nuts, then sprinkle the dry pudding mix over the top. Drizzle on the melted butter. Cover and let stand in the refrigerator overnight. In the morning, bake in a 350° oven for 30-35 minutes.

State budget drags forward as session days dwindle

With less than two weeks left in the session, the 108th Legislature is dragging an overburdened \$12.975 billion budget to the finish line.

Passing the budget is the only thing lawmakers are constitutionally required to accomplish. As introduced by the Appropriations Committee, the budget proposal would result in a projected ending balance of almost \$715 million above the 3 percent required minimum reserve. This amount would be available to fund proposals pending before the Legislature this session.

That would leave almost \$990 million in the Cash Reserve Fund, said committee chair Sen.

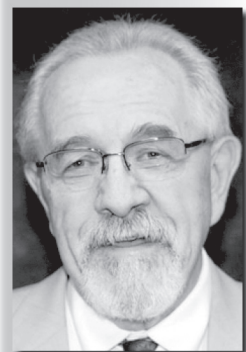
Robert Clements of Elmwood.

He said the budget reflects a two-year average spending growth rate of 2.3 percent and would leave approximately 16 percent — or two months' worth — of the state's annual expenditures in the Cash Reserve Fund as a buffer against potential future economic downturns.

Sounds good, right? But don't forget that this budget includes more than \$300 million for a new prison and nearly \$575 million for a long-discussed canal in Perkins County to divert water from the South Platte River for Nebraska irrigators relying on a 1923

interstate compact with Colorado.

Can't say that I'm warming up to the prison idea because it will simply be a replacement for the more than 100-year-old Nebraska State Penitentiary in Lincoln and do little or nothing to alleviate overcrowding in the nation's most crowded prison system.

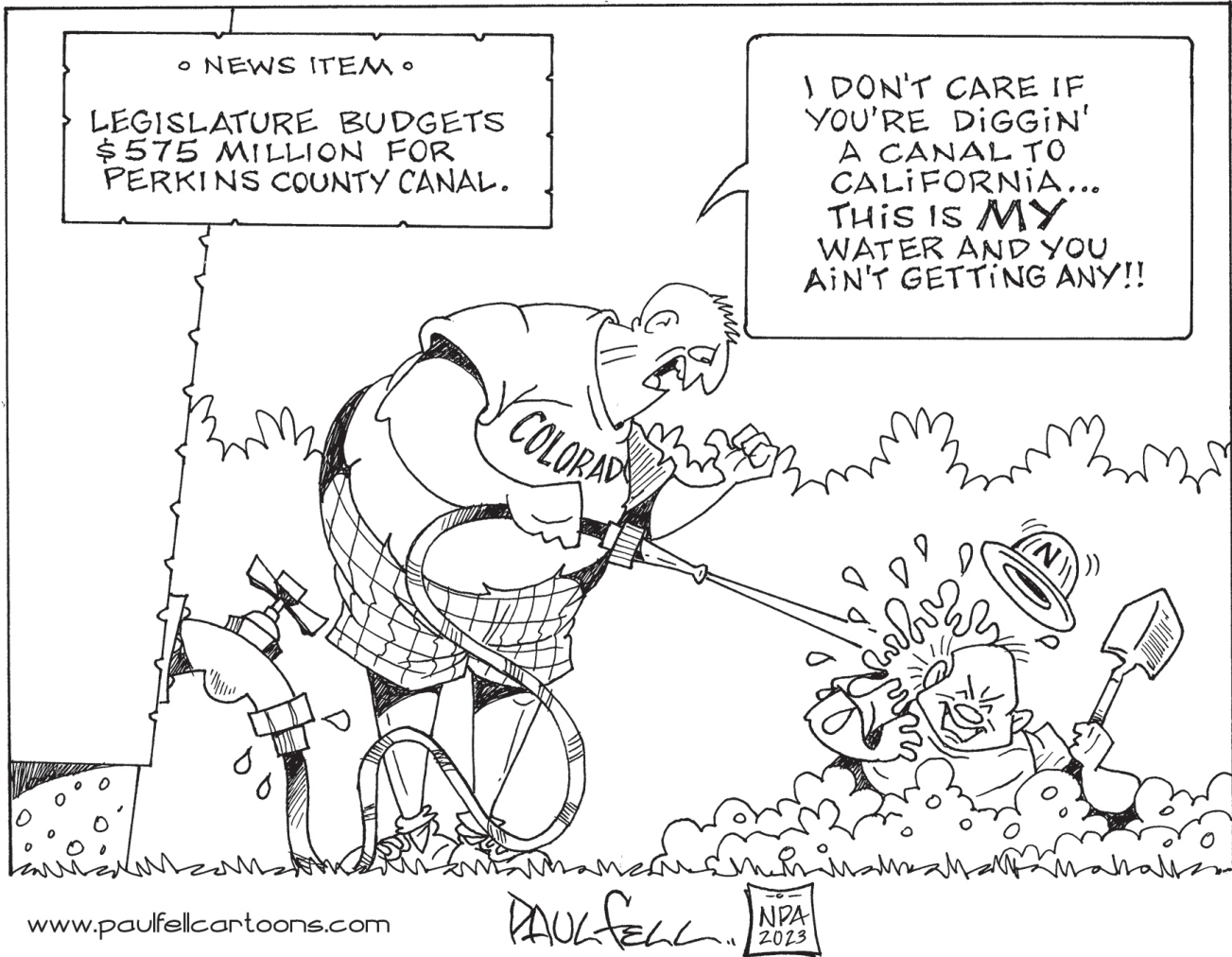
By the time it is open, there will be a need for a second new prison.

Several senators have tried to amend that expenditure by requiring extra review of the funds before they are spent on bricks and mortar. But so far, to no avail.

Judiciary Committee Chair Sen. Justin Wayne of Omaha said the state's focus on building a new facility without a comparable focus on programming for incarcerated individuals or assistance with their reentry into society is not fiscally responsible.

"Our prison system is overcrowded," he said. "We are going to spend over \$300 million to build a new prison and nobody in this body can find me any data point that says that prison will not be full the first day it is open."

Sen. Terrell McKinney of Omaha brought an amendment, adopted 29-8, to address the current grant reimbursement process for nonprofits that provide reentry services for individuals transi-

tioning back to communities from the state's correctional system. McKinney explained that many such organizations operate on tight margins and cannot afford to provide extensive services upfront and then wait to be reimbursed by the state. The amendment would require that grants not be funded through a reimbursement process.

Senator John Cavanaugh of Omaha tried to reduce the amount of money earmarked for the canal.

The state Department of Natural Resources originally requested \$449 million for a 500 cubic feet per second canal. The committee increased that request to \$574.5 million for a 1,000 cfs canal but Cavanaugh wanted to go back to the lower expenditure.

He said, and I agree, that the expanded project could jeopardize the state's ability to exert its rights under the compact by provoking backlash from Colorado over expanded eminent domain claims. Additionally, the department has failed to explain why the larger canal is necessary, he said, and building it likely would result in extensive legal battles.

In my humble opinion, either amount is likely just enough to line the lawyers' pockets before a

shovel of dirt is turned. Senators rejected the Cavanaugh amendment.

An even bigger budget burden is the \$1 billion in state general funds to provide foundation aid and additional special education funding for K-12 students through creation of the Education Future Fund.

"We funded a lot of good programs," said Revenue Committee Chair Lou Ann Linehan of Elkhorn. That includes hundreds of millions of dollars for economic development aid to east Omaha and increases in Medicaid provider rates.

"I'm tired of hearing that we don't take care of people here," Linehan said.

"The largest part of our budget is aid — by far and away."

My observation, it all sounds great until they money runs out and future Legislatures have to cut programs and services to make the cashflow work.

Promise me that you'll remember my caution a few years from now.

Confronting the crisis at our border

The lack of security at our southern border is deeply troubling, and the crisis continues to worsen. According to U.S. Customs and Border Protection (CBP), March encounters on our southern border rose nearly 25 percent over February. This crisis brings serious risks to our homeland security, grows fentanyl's scourge on our public health, and has led to a massive humanitarian crisis that has only been made worse by the policies of the Biden administration.

In the first six months of Fiscal Year (FY) 2023, CBP arrested 80 individuals listed on the terrorist

watchlist who were attempting to cross our southern border and 2 attempting to cross our northern border. These encounters total more than the number of terrorist watchlist encounters in the five years between FY17-FY21 combined.

With four months remaining in FY23, we are projected to far outpace the number of watchlist encounters at our southern border from FY22. Furthermore, human trafficking has become an estimated \$13 billion revenue source for cartel smugglers according to the Homeland Security Investigations division of U.S. Immigration and Customs Enforcement (ICE). In March, CBP fentanyl seizures increased by 25 percent over the previous month.

The lack of security at the border is affecting the security of every community around the country.

Action must be taken to confront these concerning trends, yet the policy of the Biden administration has neglected the problem and adopted a posture that incentivizes abuse of our immigration system. Since President Biden took office, CBP has recorded 1.3 million known "gotaways" at the border and over 5 million encounters.

Border officials are overwhelmed and under-resourced. Referring to the expiration of Title 42 this week, Biden admitted, "It's going to be chaotic for a while." Yet the president refuses to fill the gap being left by his administration's decision to let this effective policy lapse.

House Republicans' Commitment to America prioritizes a nation that's safe because we have a responsibility to act to protect American citizens from the inflow of lethal drugs such as fentanyl, which has become the leading cause of death for Americans ages 18-45. This week, we delivered on that commitment by passing the Secure the Border Act, a legislative solution to the ongoing gaps in our nation's border enforcement. The Secure the Border Act would boost manpower at the border, authorize investment in security enforcement technology, and mandate the resumption of border wall construction.

Although President Biden has been slow to act, maintaining homeland security — at the border and otherwise — does have some bipartisan support. This week, a bill I introduced alongside a bipartisan group of colleagues advanced out of the House Agriculture Committee with unanimous support. If enacted, the bill would reinforce the program that trains detector dogs to assist CBP agents at the border in identifying and stopping prohibited agriculture items that could carry foreign pests and diseases before they enter our food supply. Protecting American consumers and producers against these threats is of the utmost importance. I'm pleased to see this bipartisan bill advance in the legislative process, and I am eager to see its passage by the full House.

The federal government cannot sit by while American lives are lost because our borders are not secure. The Secure the Border Act and my agricultural security bill are strong, commonsense bills. To confront our border crisis, we must act on solutions to counter the administration's ongoing failure to address this issue.

Bill to create Nebraska Broadband Office amended

The Legislature gave second-round approval to the budget bills this past week. This effort will allow the budget to be read on Final Reading next week, meeting the require-

ment to have it pass by the 80th legislative day. The budget would provide money for capital construction projects such as the Perkins County Canal Project and a new prison facility.

Additional funds are appropriated to cover salary increases recently negotiated with the state employee's union and for staff at correctional facilities and other 24/7 facilities that were experiencing dangerous staffing shortages.

Worker shortages and competition also necessitated provider rate increases for nursing homes, behavioral health providers, developmental disability providers, and other

Medicaid service providers.

In addition to the budget, other major legislation was considered by the Legislature. LB 705 is one of the Education Committee's priority bills for the year.

The underlying bill would distribute over \$24 million in state lottery funds to various education sources, including college access and opportunity grants. LB 705 was amended to include provisions from 22 other bills which cover a broad range of subjects such as mental and behavioral health resources, credentialing, and teacher recruitment and retention.

The latter is a concern for lawmakers since the state is experience a worsening shortage of educators, particularly in rural Nebraska. According to the Nebraska Department of Education, unfilled teaching jobs across the state increased by nearly 60% over last school year, going from 482 vacancies at the start of the 2021-22 school year to about 768 at the beginning of 2022-23. Following a filibuster in protest of LB 574, LB 705 was advanced to Final Reading on a 39-4 vote.

LB 683, which would create the Nebraska Broadband Office, was amended to include provisions of LB 63 to prohibit a telecommunication company from receiving sup-

port from the Nebraska Universal Service Fund if said company is using or providing any communications equipment or service deemed to pose a threat to national security. A rising concern is the presence of Chinese equipment on Nebraska telecommunications infrastructure, which could allow China to monitor domestic communications and collect intelligence near sensitive sites such as the missile silos in the Panhandle.

An amendment was brought forward to make this prohibition immediate. Senators supported the amendment on a 40-0 vote.

LB 562 would create the E-15 Access Standard Act and increase consumer access to E-15 fuel. An amendment was offered by the Agriculture Committee to address concerns raised by distributors and the petroleum industry.

This amendment would clarify the waiver requirements for distributors and increase a refundable income tax credit program to retailers for every gallon of E-15 and higher blends sold to minimize the burden on gas stations as they make the transition.

During debate, Senators attached provisions to LB 562 which would expand the eligibility requirements for the Beginning Farmer Tax Credit Program and standardize the permitting and inspection processes for food trucks. The Agriculture Committee amendment was adopted on a 41-0 vote before lawmakers advanced LB 562 to Final Reading on a voice vote, a rarity in this year's legislative session.

LB 583 would increase state aid to public schools by ensuring the state provides eighty percent of a school

district's special education funding needs when combined with federal funding.

Additionally, school districts would receive \$1,500 per student as foundation aid as a component to the TEEOSA school funding formula. This bill would also provide an additional \$300 million in aid to public schools on top of the \$1 billion currently provided by the state.

LB 583 was advanced to Final Reading on a voice vote.

Taxes were also a topic of discussion. LB 243 would increase the minimum amount of relief granted under the Property Tax Credit Act and makes other changes aimed at easing the financial impact of increasing property tax valuations on Nebraska's local property taxpayers.

LB 754 would reduce the state's personal income and corporate income tax rates as well as accelerate the phasing out of income taxes on Social Security. Work continues on both bills, but they are on hold final consideration until the budget passes.

Looking ahead, the Legislature will take up the budget bills on Final Reading before sending them to the Governor's desk for approval. Additionally, debate will begin on amendment AM 1658 to LB 574 which would combine restrictions on gender-altering surgeries with a revised version of LB 626 that creates a 12-week abortion ban with exceptions for rape, incest, and life of the mother.

PLAINVIEW — It's not often that the moment you've waited for is in front of your eyes. Yet, on Wednesday afternoon, it was all in front of Wolfpack senior sprinter Camryn Pelster.

One hundred meters lay directly in front of him. Cross the finish line in first or second place and qualify for the NSAA State Track & Field Championships.

Pelster, a senior, has spent his varsity years being a sprinter. Lining up in the starting blocks waiting for the starter's pistol to go off, then turn on the jets.

He's probably lost track of the number of 100 meter dash events he's competed in. There's really no reason to count because track isn't about scoring points, runs or goals. It's the simplest form of sports, just beat your opponent across the finish line. It's easier said than done.

First off, the race itself can't be won at the start, but it can be lost. If you are slow out of the blocks, you fall behind and it's hard to catch up in such a short distance. That's why the first 10 meters are so important. You can't false start or you will be disqualified. So, to use a quote first spoken by John Wooden, "be quick but don't rush."

I've watched young Pelster race for four years now and, on Wednesday, there seemed to be an inner confidence in the young man, not cocky but confident.

And it showed in the finals. Pelster got a great start out of the blocks, something akin to a cannonball being fired out of a cannon. Running in lane #4, reserved for the fastest qualifier, Pelster had to his left teammate junior Myles Kittelson.

They were side by side at the start, then Pelster inched his way into the lead. With 10 meters to go, fans could see Pelster was going to win the race.

As he crossed the finish line, Pelster raised his fist into the air in celebration. He had won the biggest race of his high school career, earning a trip to state where he will now face the best of the best in Class D.

And, in those 10 seconds from the starting gun to the finish line, he had achieved one of his goals.

There's something about being a 100 meter spring champion, a certain attitude of being the fastest man on the track. Call it what you want, whatever it is, he suddenly was in possession of it.

Wolfpack fans were happy for Pelster. I, for one, was elated.

There's nothing more satisfying in sports than to rise to the occasion - to be your best when you need to be your best.

Then, before the end of the day, the Wolfpack's school-record 400 meter relay team of Pelster, Kittelson, Corbin Kinney and Dylon Lueking qualified for state as well, making it a great day for the Wolfpack.

Of all the Wolfpack athletes headed to state, Kittelson will be the busiest.

Not only did he qualify in the 100, he also qualified in the 200 meter dash and in the long jump.

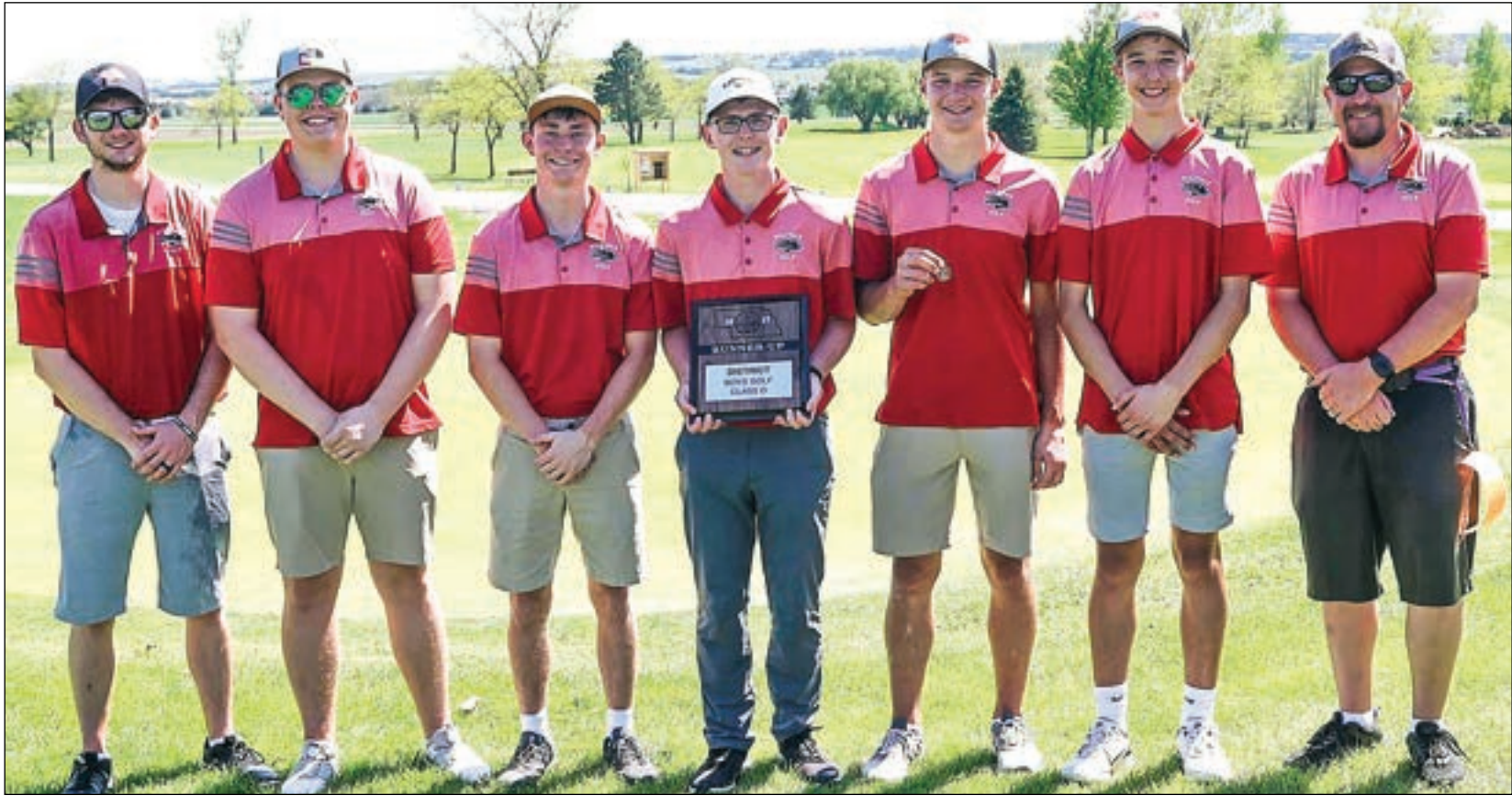
Correct me if I'm wrong, but I don't think there has been a Wolfpack athlete who has competed in four different events at the state track meet.

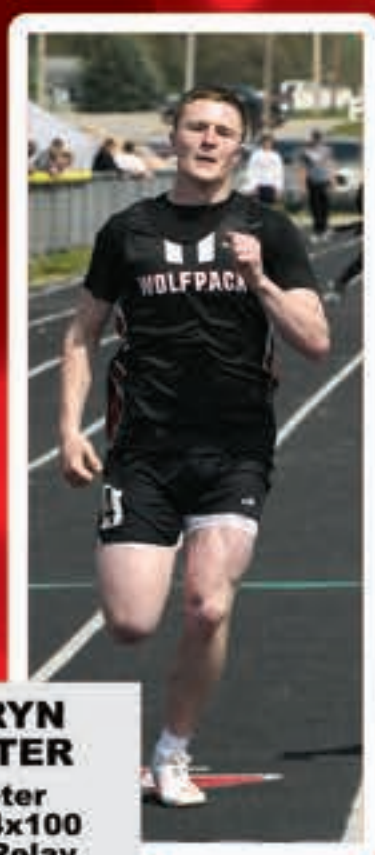

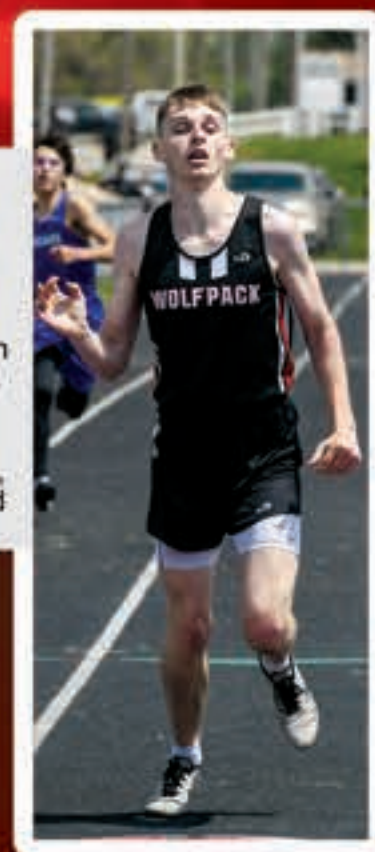

Weeds in your spring pastures

If your pasture had weed issues last year, chances are that some of those same plants will be making a comeback again. Many times, we fail to notice weeds until they become a major issue we have to deal with, which is well past the point our control measures are most effective. From ragweed to thistles, being proactive with management can make your weed problems easier to manage this year.

As with any pest issue, the first step for pasture weed management, is proper identification. Often weeds that may have been a problem are annual species taking advantage of weather conditions. We often see this during or following a dry period, where species like ragweed, snow-on-the-mountain, and sunflower come out in force.

The cheapest way to deal with these opportunistic invaders is with proper grazing management. Research on ragweed in pastures has shown that numbers are worst in pastures with an open canopy during the late May-June time period. Not only does this provide sun and space for seeds to germinate and grow, but also shows that the surrounding plants are dealing with some sort of stress and will not be as competitive as normal. By providing proper rest and strengthening the health of pasture plants we want, annual weeds can be out competed.

In severe cases, herbicides can help control these problems, but I'm a fan of trying grazing management first. Often annual weeds are a symptom of deeper issues, not the cause. In some cases these species can be beneficial, providing cover and keeping something growing during droughts. We just don't want them to end up taking over.

On the other end of the spectrum are weed species we know we will have to deal with. Species like musk thistle, leafy spurge, and any other weed on a state or local noxious weed

lists are on another level of aggression. These plants can establish a foothold and despite our best management, slowly take over a pasture.

While grazing properly can help slow spread, we typically need to take additional control measures to get these problem weeds under wraps. For our thistle species, plumeless, musk, and Canada, herbicide treatment works best when they are still in the rosette stage, which

is right now.

While they may be a bit more difficult to spot as a low growing rosette, control now means very few plants will live to produce seed this summer. For annual species like plumeless and musk, this can greatly reduce numbers the following year. If this management is repeated for multiple years in a row, infestations can be brought to heel.

Some herbicide options to consider include Milestone, GrazonNext, Gunslinger P+D, Chaparral, Cimarron, Curtail, or a tank mix of dicamba and 2,4-D. Select the herbicide that best fits your operation. Some on this list may have action against other problem weeds, essentially giving you a 2 for 1 deal if applied correctly.

Perennial species like Canada thistle pose a bit more challenge. Herbicide application may not always kill a well-established perennial plant, but still may serve a purpose by weakening it and preventing seed production. Rosette applications of Curtail, WideMarch, Telar, Cimarron,

or Gunslinger P+D are all options to consider. For all herbicides, always be sure to read and follow the label's directions when applying.

Managing pasture weeds starts now in the spring. Whether changing grazing management or using a herbicide treatment, properly identify the target, choose the option that makes sense, and apply the control in a timely fashion. Time spent well now will result in less weed issues this summer and fall.
